Rules

- 1: The name of the draw is The Wargrave and Shiplake Regatta (WSR) "150th Anniversary Club".
- 2: The objective of the Lottery is to raise funds for the general purpose of the WSR Charity.
- 3: The Lottery will be administered by a Promoter appointed by the WSR committee.
- **4:**.The Lottery shall run continuously from the 11th May 2015 with the first draw taking place at the end of July 2015.
- 5: The Lottery will be open to anybody aged 16 or over.
- **6:** The of subscriptions in the Lottery shall be limited to a maximum of 300 and each subscription shall be allocated a unique number. Numbers will be allocated in sequence when applications are received. Participants are entitled to hold any number of subscriptions.
- **7:** There shall be a draw made in the last week of each quarter (July, October, January, April) using the automatic random number generator on www.random.org.
- **8:** The subscription for each number is £15 per quarter payable in advance; if subscriptions are not received for the quarter before the draw the numbers will not be included in the draw. The Promoter reserves the right to reallocate any number where payment has not been received.
- **9:** 25% of the total quarterly subscriptions will be awarded as prizes dependent on the number of active members during the quarter. This is illustrated in the table below:

- **10:** Winners will be notified by email and will be paid by cheque. It is the responsibility of the participant to advise the Promoter of any changes of email and postal address. Any prize cheque not cashed within 6 months will be deemed a donation to the Club. Winning numbers will be published on the website.
- **11:** Participants can cancel their entry in the Lottery at any time by giving one quarter's written notice to the Promoter. Any decision by the WSR Committee to end the Lottery will take force after the next Lottery draw, with notification to all Participants of not less than one quarter. Direct debits will be cancelled.
- 12: Under no circumstances can subscriptions be refunded.
- **13:** The Promoter will determine any dispute. An appeal may be made to the WSR Committee whose decision shall be final.
- **14:** The Lottery is intended to be a Small Society Lottery under the provisions of the Gambling Act 2005.
- **15:** The Charity may amend or vary the rules of the lottery at any time. The rules of the Lottery will be available via the website. Changes will be notified to Participants via the website and via email.
